#### RECOGNITION ORDER

- 1. - 3. NOW THEREFORE, in exercise of the powers vested under Section 14 (3) (a) of the NCTE Act, 1993, the Western Regional Committee hereby grants recognition to **DEPARTMENT OF EDUCATION AKS UNIVERSITY, PLOT NO 200/1K1, 200/1K2/2, STREET NO 1, VILLAGE SHERGANJ, P.O MAHDEVA, TEHSIL RAGHURAJ NAGAR, DIST. SATNA 485001, MADHYA PRADESH (WRCAPP188)** for starting **B.Ed. (CO-ED)** Course of Secondary level of **1 Years** with an annual intake of **100 from the academic session 2014-2015.**
- 4. Further, the institution is required to comply with all post-recognition conditions enumerated from Clause 8(11) to Clause 8(16) of NCTE (Recognition, Norms & Procedure) Regulations, 2009.
- 5. - 6. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms and Procedure) Regulations, 2009.
- 7. The institution shall ensure that the required number of academic staff for conducting the course is always in position.
- 8. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its Official website.
